EAC WRIST BANDS:

Upon arrival at the show site, EAC's will be required to check-in at the designated area to confirm that all the paperwork is completed and to receive further instructions to begin working. Admittance will be denied until all paperwork is received.

EAC's must have the appropriate color wrist band on each day to enter the exhibit hall. Please instruct your EAC's to check in at the back dock of the Exhibit Hall. EAC's that have not presented the Certificate of Insurance will not be allowed access to the exhibit hall. Equipment and furnishings supplied by the EAC to the exhibiting company are subject to the current drayage rates and will be billed to the exhibiting company.

SECURITY PASSES FOR PRE- AND POST-SCHEDULED EXHIBIT HOURS

Exhibitors may escort clients into the exhibit hall before or after scheduled exhibit hours with a pre-arranged demo-pass.

Demo-passes are only available onsite and must be obtained prior to attendees entering the exhibit hall. All attendees <u>MUST</u> be registered and must have an I/ITSEC badge in their possession. Attendees who are not registered will not be permitted access to the exhibit hall with the exhibitor. To obtain your demo-pass, please visit the Show Management Office located in Room 220AB.

Under no circumstances will exhibitors be allowed to escort a client into the exhibit hall without a demo-pass. In addition, clients will not be allowed access to the exhibit hall without both the exhibitor and demo-pass.

IMPORTANT SECURITY INFORMATION

I/ITSEC Show Management is taking precautions to safeguard your property by providing perimeter security. We suggest that you take additional steps that will reduce your chance of loss.

Never Leave Your Exhibit Unstaffed – even for a brief time during show hours.

Hire A Booth Monitor – Century Booth Monitoring Staff is available specifically to monitor your exhibit and products. You may order Booth Monitors by completing the form in the exhibitor manual, or by contacting Century Security Management.

Storage – Please see The Expo Group for secured storage available to store valuable items. We strongly recommend that you utilize these services to secure your valuables.

Removal – Pertinent component parts should be removed from displays or floor models after demonstrations. **Never Leave A Prototype Unprotected.**

Covering – Drape your product with a flame-resistant cover. The cover will be a "Snatch and Grab" deterrent.

Never Leave Purses, Briefcases, Or Other Valuables Under Draped Tables or Behind Draped Booths.

Pack all exhibit products as soon as the tear down begins. Thefts tend to occur during this period.

Reporting – If you should experience a loss, please notify I/ ITSEC Security Hotline at (407) 685-6111. A Manager will contact the Orange County Convention Center Security Office, and a Security Representative will respond and document the circumstances.

Protect your booth/exhibit:

Report all attempts to acquire/export restricted items.

Do not allow connections to company servers (via thumb drives, flash drives, etc.)

Scrub all company electronics for malware/spyware at the conclusion of I/ITSEC

EXHIBIT COORDINATOR LUNCH

2025 I/ITSEC SUSTAINING MEMBER | BOOTH SELECTION INFORMATION

(CONDUCTED IN THE SHOW MANAGEMENT OFFICE - ROOM 220AB)

Sustaining Member booth selection for I/ITSEC 2025 will take place in Room 220AB. Sustaining Members will be given daily times based on the current size of booth space taken in 2024. If you miss your appointment, you will not be allowed to "move" in front of the person that arrived before you; you must wait until there is an opening in the schedule. To be fair to everyone, this rule will be STRICTLY enforced, please make your appointment on time.

Exhibitor appointment days, contracts and floor plans will be made available at the show office on Saturday 30 November starting at 0900. Exhibitor coordinators must sign for the package at the Show Management Office. Please ensure that you send someone prior to booth selection to pick up your selection package.

Selection is contingent on a deposit of 50% to be received onsite. A credit card will be **REQUIRED**, regardless of payment method. If a credit card is not provided in the contract, booth space will not be assigned, and exhibitors will have to re-book at a later date.

If you have any questions about your selection time or the criteria required receiving an earlier time, please inquire at Room 220AB.

GOOD NEIGHBOR POLICY

Please be respectful to your neighbors on the exhibit floor. Keep audio and demonstrations at an acceptable level. All exhibitors should be able to speak to customers without having to raise their voice.

All demonstrations should be conducted within your booth perimeter. Please keep all products on display in your booth. No roving products (robots, vehicles, etc.) are not permitted up and down the aisles.

Special effects lighting should not be used in a manner that will be disruptive to exhibitors around your booth. Thank you in advance for your consideration.

SAFETY TIPS

We want to make sure your experience in Orlando is a favorable one. Below are a few tips to keep in mind:

- Do not leave your laptop, purse, cell phone, etc. lying out in your booth at any time. Be sure to lock those items away or at least keep them out of visible sight. Theft should be reported to our Show Management/Security Office immediately. You will be asked to file a report. Please be sure to carry full insurance for any items in your booth. NTSA is not responsible for any lost, stolen, or damaged items.
- Report any suspicious activity of packages you see in the exhibit hall, lobby areas, docks, etc. to an NTSA representative, The Expo Group representative, or our Show Management/Security Office immediately.
- Report any non-exhibitors walking around selling products or services. This is referred to as "Suit Casing" in the trade show arena. Their badge will indicate if they are an exhibitor or an attendee. If they are reported immediately, NTSA can have them removed from the show floor.
- Avoid wearing your show badge outside of the convention center. Do not wear it to restaurants, bars or walking on the street as you will immediately be identified as a tourist.
